

## CITY PARK REGULATIONS

The purpose of these regulations is to assure respect for all visitors and encourage a positive experience for all.

1. All campers must register before setting up camp, this also includes day riders.
2. No portable pens or electric fencing are allowed. Please use picket lines or corals provided.
3. Campers who stake or hobble horses are encouraged to be courteous of other campers. Staked animals must be staked in day ride parking side closest to you from across where you camp and must not be able to reach road. Hobbled horses must have lead rope and camper must have control of rope. **NO ANIMAL IS ALLOWED TO WANDER AT WILL !!!**
4. Manure from horses must be put in pit provided. No manure will be discarded in any other area.
5. Dispose of waste materials by placing it in receptacles provided for such purpose.
6. Dogs, cats or other pets must be kept on a leash not more than 8 feet long at all times. This includes trails leaving the campground. Owners are responsible for picking up after their dogs in campground. No person may allow his or her pet to interfere in any manner with the enjoyment of the area by others. If dogs accompany riders on private ground trails, they must have permission of that land owner and must be under control of the rider and pose no problem for other riders. No dogs will be allowed on park horse trails without a leash. Dogs running loose with leash are considered in violation of park rules.
7. Fires are allowed in grills and fire rings and should not be left unattended.
8. Violent, abusive, indecent, profane, boisterous, unreasonably loud or disruptive conduct will not be allowed.
9. Please observe all "closed trail" signs and stay on designated horse trails. Many of the trails are private property, be courteous of the land owners.
10. There will be NO saving spaces for other campers, the parking of vehicles and equipment in a manner that prevents other campers from parking next to you is prohibited.

11. You must have a horse or be part of a riding group to camp in this area of LaRiviere Park.
12. Generators may be used between the hours of 8 a.m. and 9 p.m.
13. Campers may NOT exceed 10 (ten) continuous days. Upon the end of 10th day campers must vacate premises for a minimum of 48 hours before returning to campgrounds.
14. All campers must be provided the use of hitch and/or picket lines in their own camping space. Upon the arrival of campers, horses not of that camping area must be removed immediately.
